 entities acting for the benefit of the disabled, consisting of on their financial support,
- to apply objective and fair criteria of assessment of employees and their performance,
- to treat all staff members with dignity and respect,
- to obey the applicable laws regarding working hours and holidays,
- to timely pay remuneration in the amount of at least the minimum wage applicable in Poland in a given year,
- to meet the employees' needs, within the possessed social means and funds,
- to facilitate professional employee development,
- to create favourable conditions for adaptation to proper work performance for employees taking up employment after having graduated from a vocational school or a school of higher education,
- to influence shaping of rules of social conduct at workplace,
- to prevent corruption and educate employees in that respect,
